The annual UK membership fee is **£40**. Those in full-time education in the UK are eligible for the special student rate of **£30**; this concession starts in September and finishes the following August, reflecting the academic year. Please enclose a photocopy of your student card when applying. There is an additional Air Mail surcharge of £5 for members in the EEC making a total of **£45** and £10 for members outside the EEC making a total of **£50**.

If you pay UK tax, Gift Aid enables us to reclaim tax on your subscription, **without any charge to you**, whilst benefiting the Society. In order for CLAS to reclaim the tax on your payments, you must be paying an amount of UK income tax or capital gains tax at least equal to the tax we reclaim from the Inland Revenue (currently 25p for every £1 you send).
